



Burn Out Event

Rules Regs and Entry Form

1. Participants may not be under the influence of alcohol or drugs
2. (Random breath tests may be done)
3. Two minute limit on burn out.
4. If wheels leave the pad you must stop and reposition bike.
5. Non- compliance will lead to disqualification.
6. \$10.00 Entrant fee must be paid prior to doing burnout.
7. Indemnity form must be signed and hand must be stamped.
8. Driver must go directly to burn out pad and directly back.
9. No laps to be done in or around the oval.
10. Helmets, long sleeves, pants and closed in shoes MUST be worn.
11. If tyre or engine blows the vehicle must be stopped immediately.
12. No fuel, oil or fluid leaks.
13. Participants must be over 16 years of age. If under 18 years of age parent or guardian must consent to participation.
14. Participant eliciting the most crowd noise will be the winner.
