1. Participants may not be under the influence of alcohol or drugs
2. (Random breath tests may be done)
3. Participants must assemble at the start line.
4. The first across the finish line is the winner.
5. Leaving the start line before the start of the race will result in disqualification.
6. Non- compliance will lead to disqualification.
7. \$10.00 Entrant fee must be paid prior to participating.
8. Indemnity form must be signed and hand must be stamped.
9. Helmets, long sleeves, pants and closed in shoes MUST be worn.
10. If tyre or engine blows the vehicle must be stopped immediately.
11. No fuel, oil or fluid leaks.
12. Participants must be over 16 years of age. If under 18 years of age parent or guardian must consent to participation.
